Re: Cedarville University - Illegal Recording and Confidential Letters

Dear Mr. Keeney:

This law firm represents Cedarville University (“Cedarville”). Please direct all communications concerning this matter to the undersigned.

Cedarville has been alerted to the fact that an illegally intercepted recording of a conversation between a student and an administrator, Dr. Milliman (the “Recording”) is currently posted on coderguy.com. The Recording is posted at:

The Recording was created without the knowledge or consent of Dr. Milliman or Cedarville, and our investigation has led us to conclude that the Recording was made with the intent of committing tortious acts against Dr. Milliman and Cedarville. The interception and use of the Recording violates both federal and Ohio wiretap statutes.

In addition to the Recording, two letters disclosing confidential information in violation of Cedarville’s handbook (the “Letters”) are currently posted on coderguy.com. The Letters are posted at:

As we are sure you are aware, the Communications Decency Act provides a zone of comfort to allow hosting providers to remove offensive content which is posted by third parties without fear of reprisal from the posting parties. On behalf of Cedarville, we ask that Alpha-



Also, Cedarville anticipates that the Recording and Letters will shortly become the subject of litigation unrelated to Alpha-USA. Cedarville requests that you take all steps necessary to preserve and maintain all documents and all electronically stored information, of any kind, in any form, and wherever located (including private files and home computers) that refer or relate to the Recording or to the Letters, including but not limited to how the Recording and Letters were placed on Alpha-USA servers.
